### Billing & Payment Information

I am aware that Aspire Arts Academy will give me an invoice via 3-5 weeks prior to the start of the upcoming term. If I wish to re-enrol into the upcoming term, no action is required after my initial enrolment. Priority placement is held. However, I understand that my placement is only held if my account is paid by the due date. Fees are due and to be paid on a **pre-paid basis** unless prior arrangements have been made. **Fees that have not been paid in the first two weeks of term will incur a \$20 late admin fee.** Cancellation after the commencement of a term incurs the full class fee. Payment can be made by direct bank transfer (acc details on website). Any cheque, cash or eftpos payments need to be taken to the reception desk between the hours of 3.30 and 5:30 Monday-Thursday.
